The European Union (Withdrawal) Bill - Update

The European Union (Withdrawal) Bill, previously known as the 'Great Repeal Bill', passed its second reading in the House of Commons on the 11 September 2017. MPs will next consider the Bill in a Committee of the whole House on a date yet to be announced.

New Legislation

Environmental Impact Assessment (Agriculture) (Amendment No.2) Regulations (Northern Ireland) 2017 SR198

The EIA Directive ensures that projects likely to have significant effects on the environment are subject to an environmental assessment prior to their approval or authorisation. These Regulations amend the

existing EIA (Agriculture) Regulations 2007 to bring into effect changes, made in 2014 by EU Directive 2014/52.EU.

The following are some of the main changes made by the 2014 Directive, which this Statutory Rule gives effect to:

- · A full and detailed definition of the EIA process
- Introduction of a co-ordinated procedure for projects that are subject to the Habitats or Wild Birds Directives as well as the EIA Directive
- Introduction of a more detailed list of information that the applicant must provide for the screening application
- Clarification of the options for screening and amendments to the information that is required when screening projects to determine whether the EIA Directive applies
- Introduces a requirement that the competent authorities must publish their screening decisions and explain the reasons why an EIA is needed or not.
- · Amendments to the information to be included in the environmental statement
- A requirement that the applicant must ensure that an environmental statement is prepared by competent experts, and that the competent authority must have sufficient expertise to assess the environmental statement.
- · Amendment to take into account the new minimum period of 30 days for public consultations
- · Details what information should now be provided within decision notices.

The Alternative Fuels Infrastructure Regulations 2017

The Alternative Fuels Infrastructure Regulations 2017 impose a common set of standards and functionality for the provision of certain alternative fuel infrastructure (electricity and hydrogen for vehicles and seagoing ships at berth). This will ensure that users of electric or hydrogen powered vehicles and berthed seagoing ships can be confident of using the right infrastructure to the appropriate standard.

The Regulations come into force on 09 October 2017

The Alternative Fuels Infrastructure Regulations 2017

EU Regulation 2017/1505/EU: Amending Annexes I, II and III to Regulation (EC) No 1221/2009 of the European Parliament and of the Council on the voluntary participation by organisations in a Community eco-management and audit scheme (EMAS)

This regulation consists of 3 articles and an annex; which in turn contains annexes I, II and III of Regulation 1221/2009, revised and adapted according to the requirements of ISO 14001:2015.

Companies are required to adapt their EMAS management systems before 14 September 2018, which is also the deadline date for transitioning environmental management systems to ISO 14001:2015.

The Regulations came into force on 20 September 2017




CAFRE Management Notes (September 2017)

EU Ban on inefficient vacuum cleaners

Inefficient vacuum cleaners that produce more heat and noise than suction will be banned once stocks run out.

Vacuum cleaners using more than 900 watts and



emitting more than 80 decibels will be banned when stocks run out.
