New on NetRegs



NEW GPPs available on NetRegs

Our Guidance for Pollution Prevention (GPP) documents provide regulatory guidance on specific activities/sectors. We have recently reviewed and updated the following GPP:

GPP20 Dewatering underground ducts and chambers.

Other GPPs available:

- <u>GPP 2: Above ground oil storage tanks</u> For above ground oil storage, excluding oil refineries and distribution depots.
- GPP 4: Treatment and disposal of wastewater where there is no connection to the public foul
 sewer

For selecting the correct sewage disposal, treatment and disposal options, and maintenance and legal requirements. Also, for what to have in mind, in terms of wastewater treatment, when buying a house.

- GPP 5: Works and maintenance in or near water For construction or maintenance works near, in, or over water.
- <u>GPP 8: Safe storage and disposal of used oils</u>
 For storing and disposing of used oils. Applies to activities ranging from a single engine oil change to those of large industrial users.
- <u>GPP 13 Vehicle washing and cleaning</u> For washing and cleaning any vehicle using automatic wash systems, high pressure or steam cleaners and washing by hand.
- GPP 19: Vehicles: Service and Repair
 For work in garages and vehicle service centres.
- <u>GPP 21: Pollution incident response planning</u>
 For producing emergency pollution incident response plans to deal with accidents, spillages and fires.
- <u>GPP 24: Stables, kennels, catteries</u> For managing and operating stables, kennels and catteries.

New Legislation



The Aerosol Dispensers (Amendment) Regulations 2018

These Regulations amend the Aerosol Dispensers Regulations 2009. The amendments update existing safety requirements by increasing the maximum allowable pressure of certain aerosol dispensers. They also align the labelling requirements for aerosols dispensers to with the provisions in the EU Regulation on Classification, Labelling and Packaging (Regulation (EC) No 1272/2008).

Consultations



Proposed Nitrates Action Programme (Amendment) Regulations (Northern Ireland) 2018

The Department of Agriculture, Environment and Rural Affairs is currently consulting on proposed amendments to the Nitrates Action Programme Regulations (NI) 2014 which will come into operation on 1 March 2018. The proposed amendments reflect the new values for the Nitrogen and Phosphorus contents of poultry litter as a result of further research which was carried out.

Table 1c of Schedule 1 values have been updated except for fattening ducks, it now also includes livestock types, categorised by age range for Broilers and Turkeys as well as including some additional categories.

Table 2 of Schedule 1 values have been updated for Pig slurries, Poultry manures, Farmyard manures (for goats and horses), also separated pig slurry (solid portion) under miscellaneous manures. It also replaces the livestock types, so that they are now categorised by age range for Boilers and Turkeys under Poultry manures, as well as including some additional categories.

The consultation closes on 31 January 2018.

DAERA announces changes to CAP Area Based Schemes for 2018

The Department of Agriculture, Environment and Rural Affairs (DAERA) has announced changes to Common Agricultural Policy (CAP) area based schemes for 2018.

These changes are as a result of amendments agreed in Brussels to EU regulations in December 2017.

NIEA Surface water abstraction – Monitoring plan guidance

The Northern Ireland Environment Agency (NIEA) monitors and controls abstraction and impoundment of water in Northern Ireland under the Water Abstraction and Impoundment (Licensing) Regulations (Northern Ireland) 2006.

All operators who have applied for a licence to abstract from surface water under the regulations are required to produce a monitoring plan at least 2 months prior to commencement of the operation.






The purpose of this document is to provide

- Why monitoring of surface water abstractions is required,
- what is required in a monitoring plan, and
- flow monitoring returns required by NIEA.
