New Legislation



Waste (Fees and Charges) (Amendment) Regulations (Northern Ireland) 2018 SR 91

These Regulations came into operation on 7th May 2018 and amend regulation 4 of the Controlled Waste (Registration of Carriers and Seizure of Vehicles) Regulations (Northern Ireland) 1999, which sets out the charges for registration as a carrier of controlled waste.

They also amend regulation 18 of the Waste Management Licensing Regulations (Northern Ireland) 2003, which sets out fees in relation to registration of an undertaking or establishment carrying out activities exempted from the requirement to obtain a full waste management license; and paragraph 3(10) of Schedule 4 to the Waste Management Licensing Regulations (Northern Ireland) 2003, which sets out fees in relation to the registration of brokers of and dealers in controlled waste.

The Regulations came into force on 07 May 2018

Radioactive Substances (Modification of Enactments) Regulations (Northern Ireland) 2018 SR116

These Regulations come into operation on 1st June 2018. They are part of a package of measures to transpose Council <u>Directive 2013/59/EU</u>RATOM laying down basic safety standards for protection against the dangers arising from exposure to ionising radiation. Most of the transposition measures are being dealt with by amending or replacing existing statutory instruments.

These regulations cover provisions in relation to planned public exposure situations and existing public exposure provisions by amending the Radioactive Substance Act 1993, the Radioactive Substances Exemption (Northern Ireland) Order 2011, the High-activity Sealed Radioactive Sources and Orphan Sources Regulations 2005, the Radioactive Substances (Basic Safety Standards) Regulations (Northern Ireland) 2003 and the Radioactive Contaminated Land Regulations (Northern Ireland) 2006. These Regulations also implement some additional measures to streamline and clarify existing legislation.

The Regulations come into force on 01 June 2018

Consultation on proposed Marine Plan

The Department of Agriculture, Environment and Rural Affairs (DAERA) is consulting on the proposed Marine Plan for Northern Ireland. When adopted, the plan will primarily be used by public authorities taking decisions which affect or might affect the marine area. It may also be used by anyone who has an interest in the marine area, including those bringing forward proposals and stakeholders who wish to comment on such proposals. You are invited to express your views on the proposed marine plan.

Updates



DAERA secures derogation in three-crop rule for Northern Ireland

The severe weather and near constant rainfall in winter and spring this year has left farmers well behind with planting. In many cases they have been unable to plant the range of crops they would normally manage.

This could have meant that they failed to meet the requirements of the Crop Diversification rules, and would have therefore failed to qualify for the Greening payment.

However Phil Hogan, the EU Agriculture Commissioner has just announced his intention to agree a derogation from the requirements for crop diversification for farmers in Northern Ireland in 2018. If growers are unable to meet all the requirements of Crop Diversification in 2018, because of the severe weather, then they can make decisions as to the best crops to plant to meet their current situation. This will not affect their Greening payment.

An announcement that will take some of the worry away from growers who have been hard hit over the past few months.

DAERA outlines progress in tackling ammonia

The Department of Agriculture, Environment and Rural Affairs (DAERA) has announced further progress in its work to help farmers better protect the environment from the impact of ammonia. Further stakeholder forums for agriculture and environment organisations are planned throughout 2018 at which evidence will be gathered to inform the eventual Action Plan on Ammonia.
